Assessor's Report: March BOR is over. The Petitions have been mailed.

Planning Commission: Motion was made by Rogers, seconded by Pins to appoint Doran Silver to the Planning Commission. Motion carried.

Treasurer's Report: The Treasurer's Report was read. The balance of all funds is \$938,754.81.

Clerk's Report: There will be no election for Bruce Township in May.

ballfield. Roll call vote, Yeas - LaJoie, Pins, Sawyers, Marsh and Rogers. Nay, O. Motion carried.

We are waiting on the cost to pave the Parking Lot.

New Business: Discussion was held on paving 15 Mile Rd.

Spring Clean Up: Motion was made by Pins, seconded by LaJoie to have Spring Clean Up on May 18 & May 19, May 25 & 26, June 1 & June 2, June 8 and June 9.

The Township will pay for the first 500 lbs. Vouchers can be picked up at the office. Motion carried.

Our road millage needs to be put on the ballot in the August Election. Motion was made by LaJoie, seconded by Pins to put the millage renewal on the ballot in the
