

TOWNSHIP OF BRUCE
MINUTES OF REGULAR MEETING HELD ON AUGUST 9, 2018

The regular meeting of the Bruce Township Board was held on August 9, 2018 at the Bruce Township Hall with board members Pins, Rogers, Sawyers, Marsh and LaJoie present. Also present was one township resident. The Supervisor called the meeting together at 7:00 p.m. with the Pledge of Allegiance.

Public Comments: There were no comments.

The minutes of the July 12, 2018 were presented. Motion was made by Rogers, seconded by Pins to accept the minutes as presented. All were in favor, motion carried.

Motion was made by Pins, seconded by Rogers to pay the bills. Checks #9732 through #9768 were issued for a total of \$124,442.28. All were in favor motion carried.

County Commissioner Report: Commissioner MacLean was not present.

Reports of Special Meetings: The Supervisor attended a Chippewa County Road Commission Meeting.

Zoning Administrator: There have been 16 permits issued.

Assessor's Report: There will be a Tax Tribunal meeting for Mr. Belfey .No date has been set.

Planning Commission Report: There has been no meeting.

Treasurer's Report: The Treasurer's report was read. The balance of all funds is \$940,908.16.

Clerk's Report: The Primary Election was held on August7, 2018. There were 469 votes casted.

Firemen's Report: There were two fire calls.

Grounds and Park Report: The Parking Lot is done. The Park is busy.

Old Business: The bid for the Assessor's Contract was presented. The bid by Christine Ledergerber was \$31,500.00. Motion was made by Marsh, seconded by Rogers to accept the bid

of \$31,500.00 from Christine Ledergerber. Roll call vote: Yeas, Marsh, Sawyers, Rogers, Pins and LaJoie. Nays: None. The bid was accepted.

Website: It is being worked on.

At the meeting held on August 9, 2018 a preamble and resolution was offered by Pins and seconded by Rogers. The Township at its meeting held on March 27, 2018 adopted its 2018-2019 Budget after proper notification and a public hearing. For the 2018 levy the following millages will be levied upon property located within this taxing unit, as set forth on the "2018 TAX REQUEST".

Roll call vote: Yeas, Marsh, Marsh, Rogers, Pins and Sawyers. Nays: 0. Resolution passed.
