Approval of Minutes: Motion by Rodgers and supported by Pins to approve the October 10, 2019 regular Meeting Minutes. Motion was approved.

Pay Bills – Motion by Rodgers and supported by Pins to approve paying of the bills (check numbers 10235-10265) for a total of \$17,367.14. Motion was approved.

are current with a 30-day written notice. Motion by Pulfrey supported by Pins to send the written notice to the Assessor, notifying her that a contract review of language is requested. And a work session will be set for a future date to evaluate proposed changes to the contract. Motion passed.

E. Reservation Proclamation Request- a letter was received from the United States Department of the Interior on behalf of the Sault Tribe. Providing official notice of putting tribal owned land in trust.

Firemen's Report – There was one call for power outage due to an accident. Also, there was a portable tank skid unit that was donated to the township by Mr. Dawson.

Ground and Park Report – The dock is out of the water now.

Old Business

- A. Hall Rental Revised Hall Rental Contract was reviewed by the board and addition discussion involved more revisions that were needed. Motion by Pins supported by Rodgers to incorporate discussed revisions into the rental contract and make the contract effective 01/01/2020.
- B. Pavilion- The building at Dunbar needs to come down.
- C. Tribunal Marsh entered into a contract with an attorney to represent us in this matter.
- D. Web Site concerns/progress There was discussion on the progress relating to transferring Web Site from Lighthouse.net to Bruce Township via GoDaddy. A review of the Lighthouse Contract is needed to verify specification of funding for the Web Site.

New Business

- A. 2019 Township Paving Agreement The Board of County Road Commissioners provided a Document detailing a new contract for paving of 7 Mile from Shunk Rd to Riverside. After much discussion a motion by Pins supported by Marsh to approve the contract for paving of 7 Mile from Shunk Rd to Riverside. Roll call vote was called, Rodgers yea, Pins yea, Marsh yea, Pulfrey yea, Lajoie yea. Motion passed. Marsh will also obtain bids to enhance East 11 mile and East 14-mile roads with ditches, tree removal, and gravel.
