Call meeting to order at 7:05 PM.

Approval of Minutes of March 10, 2022–Motion by LaJoie supported by Kronemeyer to approve the Minutes of March 10, 2022, as presented. Motion passed

Pay Bills – Motion by Kronemeyer supported by LaJoie to approve the bills (check # 11230-11273including 1 ACH payments for a total of \$17,730.18) as presented. Motion passed.

County Commission Baron Report –County Commissioners passed \$175,000 of the Adult Mariauna monies to implement the use of more officers in our schools.

County Commissioner Baron sadly announced his resignation effective April 30, 2022, due to employment reasons.

The Bruce Township Board thanked County Commissioner Baron for his service to the Township and the County, he will be missed.

Reports of Special Meeting - None

Zoning Administrator – No permits were issued this month and currently only 2 permits for the year.

Assessor's Report: working on the property database. BOR had 21 petitions, most were Veteran exemptions.

Roll Call vote required with the following results Yea -Kronemeyer, Lajoie. Nay- Pins, Pulfrey. Motion did not pass. Clarification on the question of contract vs Ordinance needed. This item is tabled until such time as clarification is obtained.
- B. Is the census count correct Information from Mr. Hagen has not been hopeful due to the problems on getting access to the Census count process and the correction process. We will continue to follow up on this.
