Treasurer's Report - General fund is 792,786.78, the Road Fund is 135,588.68 and the total of all funds is 929,375.46.

Firemen's Report – Incidents – 1 head on collision where traffic controls was the main function of the Firemen. The Grass rig will be painted in the near future. 2 new staff are signed up for Fire Fighter training 1 & 2.
