# Treasurer's Report -

A. Fund Balance – CDs are \$199,064.98, General fund is \$521,374.87 and the Road Fund is \$312,571.11, for a total of all funds is \$1,033,010.96. Motion by Pins with support from Kronemeyer to cancel the 4Front checking account. Motion passed unanimously.

B. 4Front – Motion by Pins with support by Kronemeyer to approve the closing of the checking account at the 4Front bank. Motion passed.

Clerk's Report -

Firemen's Report – Incidents – 4 incidents this month, Chief Andrews continues to solicit radio bids. Training is undergoing an overhaul and is continuing. Gage supplied stuffed animals to the Fire Department for children.

Ground and Park Report – Dock has been removed from the river and park is ready for winter. Branch trimming to provide access to pontoons on the river.
